- (3) The original application filed by SM Energy incorrectly identified the Molander 22-15-161-99H 1XC well as being located in Sections 27 and 34, Township 161 North, Range 99 West, Divide County, North Dakota, and thus was advertised as such. The actual spacing unit of the Molander 22-15-161-99H 1XC well is Sections 15 and 22, Township 161 North, Range 99 West, Divide County, North Dakota.
- (4) Case No. 25965 was scheduled for hearing on July 26, 2017 to correct the advertising mistake.

- 1.
